

Terms & Conditions

1. INTRODUCTION

This Privacy Policy explains what we do with the personal data that you provide when you submit your application to participate in “Citython Barcelona 2020”.

For the purpose of applicable legislation on data protection, this Privacy Policy will be governed by the General Data Protection Regulation or Regulation [EU] 2016/679) (the “RGPD”). The company that is responsible for your personal data is the FUNDACIÓ CENTRE d’INNOVACIÓ I TECNOLOGIA of the UNIVERSITAT POLITÈCNICA de CATALUNYA, with registered office in Barcelona, in calle Jordi Girona, number 31, with tax identification number (CIF) G-65497182 (hereafter “CIT UPC” “Us” or “the Data Controller”).

2. LEGAL BASIS FOR DATA PROCESSING

If you participate in the activities organised by CIT UPC, you accept that your personal data will be gathered, used and shared by virtue of this Privacy Policy.

The gathering and processing of your personal data is based mainly on consent and the contractual and/or precontractual relationship that you have with Us.

Informed consent is the basis for sending you our newsletters via the email that you have given us.

3. PERSONAL INFORMATION THAT WE COLLECT

To participate in Citython Barcelona 2020, which is organised by CIT UPC, and to be able to evaluate your participation, we request that you provide your identification data: email, name, identity card number (DNI)/passport number, place of residence and occupation.

Your educational and professional data: occupation, name of university, university qualification.

To send you information about the activities that are organised by CIT UPC and articles relating to them, we will ask you for your email address.

4. PURPOSES

As the Data Controller, CIT UPC will process your personal data for the following purposes:

- 4.1. Manage and evaluate your registration as a participant in Citython Barcelona 2020.
- 4.2. Contact you by email to confirm that you are a participant in the events for which you have registered.
- 4.3. Contact you by email in relation to updates or communications relating to practical aspects and the agenda of Citython Barcelona 2020.



4.4. Contact you to offer you opportunities to join a recruitment process that could be of interest to you.

4.5. Where appropriate, and pursuant to legislation and local requirements, we could also use these data for marketing purposes and for drawing up profiles. Where appropriate, we will obtain your consent to carry out these activities.

5. DATA RECIPIENTS

To meet the purposes indicated in this Privacy Policy, we may need to communicate or transfer your personal data to others for the following reasons:

- Transfers to the sponsors of Citython Barcelona 2020: unless you state otherwise, we notify you that to give you the opportunity to join a selection process, CIT UPC shall communicate the Personal Data that you provide to the companies that sponsor Citython Barcelona 2020, and specifically to:
 - o EIT KIC URBAN MOBILITY SL, registered office Torre Glorias, Av. Diagonal 211 planta 27, 08018 Barcelona and tax identification number (NIF) B67513630.
 - o FUNDACIÓ BARCELONA INSTITUTE OF TECHNOLOGY FOR THE HABITAT (BIT HABITAT), registered office in Barcelona at Avenida Diagonal 240 and tax identification number (NIF) G 662 05 246.
- Company transfers: in relation to any reorganisation, restructuring, merger or sale or other transmission of assets, we will transfer information including personal information, as long as the recipient agrees to process your personal information in a way that meets our Privacy Policy.
- Service suppliers: to provide services in our name or to help us with the services that we provide in the organisation of Citython Barcelona 2020. For example, data could be transferred to service suppliers to provide marketing, advertising, communications, infrastructure and IT services, to personalise and optimise our events. For the efficiency of the service, these collaborators and providers could be situated in the United States or other countries or territories outside the European Economic Area that provide a level of data protection that is equivalent to that of the European Union.

By accepting this Privacy Policy, you authorise us expressly to process and communicate your personal data to the aforementioned companies and/or to transfer your personal data to the above service providers, who are responsible for data processing outside of the European Economic Area, for the purposes that are described here and to provide a full service. When, for the purpose of information exchange, we transfer personal information to countries outside the European Economic Area and to other areas that have comprehensive data protection laws, we ensure that the information is transferred in accordance with this Privacy Policy and permitted by current legislation on data protection.



6. DATA RETENTION PERIOD

We retain your personal data during your contractual relationship with us. On its termination, if we have not had contact with you in the following two (2) years, we will proceed to delete your data from our system (or after a longer period during which we consider in good faith that the law or another regulation obliges us to maintain them).

7. DATA PROTECTION RIGHTS

As Data Controllers, we are committed to respecting the confidentiality of your personal data and guaranteeing the exercise of your rights. At all times, you can exercise the following rights:

- 7.1) Right of access. You have the right to confirm that we are processing your personal data. If the answer is affirmative, you have the right to obtain a copy of these data and full information on how they are processed.
- 7.2) Right to rectification. You have the right to correct errors, alter inaccurate or incomplete data and ensure the accuracy of the information that is being processed.
- 7.3) Right to erasure. You have the right to request the erasure of your data without undue delay, if the data processing is unlawful, or the purpose of the data processing or data collection is no longer valid.
- 7.4) Right to limitation of processing. You have the right to request the suspension of data processing if this is unlawful or the accuracy of the data have been refuted.
- 7.5) Right to opposition. You have the right to oppose processing of your data when the purpose is direct marketing or when data processing should cease for reasons relating to your personal situation, unless a legitimate interest can be demonstrated, or such processing is required to exercise or defend claims.
- 7.6) Right not to be the subject of automated individual decisions. You have the right not to be the subject of a decision based only on automated processing, including the generation of profiles, that have legal effects or affect you, unless they are necessary for the execution of a contract, it is permitted by Law or you have given your explicit consent.

Due to the nature of our services and the purpose of the collection and processing of your personal data, the right to data portability is not applicable.

The exercise of your rights is free, unless you make requests that are clearly unfounded or excessive, in which case the interested party could be required to assume the cost of the procedure.



8. AMMENDMENTS

We will update this Privacy Policy occasionally and in response to requirements derived from legal, regulatory or operational changes. We will notify you of these changes (including their commencement), in accordance with the law.
